

The following moving violations are common violations which qualify for the CATS Program.

- Careless Driving
- Disregarding compulsory turn lane
- Disregarding Stop Sign
- Disregarding Traffic Control Device
- Failure to / Improper Signal
- Failure to Illuminate / Dim Headlights
- Failure to stop (signal, RR crossing or stop sign)
- Failure to yield
- Following too closely
- Improper Driving
- Improper lane usage (vehicles keep right except to pass or overtaking vehicle)
- Improper Passing
- Improper Start
- Improper Turn (illegal U-turn)
- Speeding (less than 26 miles per hour (MPH) over the limit)
- Too fast for conditions
- Too slow for conditions
- Vehicle not under control
- Wrong way on one-way street

## Eligible Offenses

- Speeding
- Disregarding a Traffic Control Device
- Disregarding a Stop Sign
- Loud Exhaust Violation
- Failure to Illuminate Headlamps
- Improper Equipment
- Failure to use Child Restraint Device
- Failure to or Improper Signal
- Improper Passing
- Careless/Reckless Operation of a Motor Vehicle
- Failure to Give Right of Way to Emergency Stopped Vehicle.

**You may be eligible if you were charged with:**

- Speeding 25 over the limit or less (Does not include speeding in work or school zones)
- Careless driving (Must appear in court to see if you qualify if you received this charge)
- Improper passing/Improper signal/Improper turning
- Disregarding a stop sign/Disregarding traffic control device or traffic light
- Driving too fast for traffic conditions/Driving too slow for conditions
- Failure to yield right-of-way (Does not include failure to yield to pedestrians or emergency vehicles)
- Improper lane usage/vehicles keep right except to pass
- Following another vehicle too closely
- Wrong way on a one-way-street
- Seat belt violation (Does not include Booster Seat violations or Child Restraint violations)
- Texting/Communication Device Violation

## Ineligible Violations or Charges

The following charges and/or criteria will make you ineligible for the CATS program.

- Changing Drivers in a Moving Vehicle
- Driving on Wrong Side of Roadway
- DUI
- Eluding Police
- Failure to Maintain Insurance
- Failure to Stop for School or Church Bus
- Failure to Yield to Emergency Vehicle
- Following an Emergency Vehicle too closely
- Infraction which results in an accident
- More than eight (8) points on license
- More than three offenses on this traffic ticket
- Participated in CATS Program within last twelve (12) months
- Pending misdemeanor or felony charges
- Possession of a CDL (pursuant to KRS 186.574; 49 C.F.R. § 384.226)

- Racing
- Reckless driving
- Speeding 26 miles per hour (MPH) or greater
- A violation of KRS Chapter 189 in which a mandatory license revocation or suspension occurs

You may not be eligible if you have:

- Already paid your ticket
- Signed up for State Traffic School
- A Kentucky Commercial Drivers License
- Taken the program in the last year
- Received a citation on the AA Highway for speeding 26 MPH or over or you are charged with Careless or Reckless Driving

**You will not be eligible if:**

- You were driving without a valid operator's license
- You were driving without valid insurance
- You have participated in a county attorney traffic safety program within two years
- You have a CDL (commercial driver license)
